According to the interactive tool on VT Digger article, in 2018 we performed very close to the statewide average cut score of 2507.3


TES had a proficiency scale score of 2501.8 (as shown in graph below).

In the Vermont Dept of Agency SBAC portal I was able to bring up the latest results for 2018-2019. In all grades, except Third grade in math, we scored higher or equal to the VT state average.
