

**WARNING**  
**ANNUAL MEETING**  
**OXBOW UNIFIED UNION SCHOOL DISTRICT**  
**June 30, 2020**

The legal voters of the Oxbow Unified Union School District (the "District"), comprising the legal voters, respectively, of the Towns of Bradford and Newbury, are hereby NOTIFIED AND WARNED to meet at their respective polling places, Bradford Academy Auditorium and Newbury Town Office, from 10:00 AM (when the polls will open) to 7:00 PM (when the polls will close) to vote by Australian ballot on the following Articles:

ARTICLE 1: To elect a Clerk for a term of one (1) year.

ARTICLE 2: To elect a Treasurer for the year ensuing.

ARTICLE 3: To amend the first paragraph of Article 11 of the Articles of Agreement for formation of the District to read as follows (added text underlined; deleted text struck through):

~~The Oxbow Unified Union School New Union District Board shall be composed of six (6) individuals elected pursuant to the "Hybrid Model" of board representation, in the numbers and allocation set forth for election of the initial members under Article 10(A), unless and until the voters of the New Union Oxbow Unified Union School District amend this Article 11 to change the number of Directors. Three seats on the Board are allocated to each town.~~

ARTICLE 4: To elect two school directors of said District (1 to represent Bradford and 1 to represent Newbury) each for three-year terms to expire 2023.

ARTICLE 5: If the result of the vote on Article 3 is in the affirmative, to elect one (1) school director of said District to represent Newbury for a one-year term to expire 2021.

ARTICLE 6: If the result of the vote on Article 3 is in the affirmative, to elect one (1) school director of said District to represent Bradford for a two-year term to expire 2022.

ARTICLE 7: Shall the voters of the Oxbow Unified Union School District authorize the school board to expend seventeen million, two hundred sixty-five thousand, seven hundred eighty-one dollars (\$17,265,781) which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$18,460 per equalized pupil. This projected spending per equalized pupil is 9.79% higher than spending for the current year.


ARTICLE 8: Shall the voters authorize the school board to borrow money in anticipation of tax receipts for the 2020-21 school year?


ARTICLE 9: Shall the Directors be paid \$2,000, and the Chair \$2,500 for the 2020-21 fiscal year?


A public informational hearing will be held on the above Australian ballot articles on June 23, 2020 beginning at 6:00 PM by Zoom.




