

Board Positions and responsibilities:

- Board Chair- Promotes development of a strong board team, Establishes a strong connection with the administration, Organizes (colaboraties the development of agendas with Superintendent) and conducts productive meetings, Promotes lawful and ethical operations.
- Vice Chair (Technically not required but strongly recommended)- Is the Board Chairs backup or substitute, runs meetings in case the chair isn't available. Works with the Chair and Superintendent to facilitate meetings and develop agendas.
- Clerk- Ensures meeting minutes are kept, draft minutes are available to public and posted on website within 5 days.
- Secretary- Takes meeting minutes in the absence of Minutes Clerk (paid position held by a non board member).
- Budget Clerks- two board members- (one as primary and one as back up) go to the OESU office (usually twice a month) to review and sign payables (the bills that are paid by the schools.) Each school has their own batch of payables.
- OESU Representatives: three members from the board to serve as voting members of SU board. OESU meets once a month (usually first Tuesday of the month).
- RAB (River Bend Advisory Board)- One member to sit on the RAB to represent the OUUSD and facilitate communication.
- Sick Bank- One board member to be a member of a committee to accept/decline applications to access the employee sick bank. Work with the HR department to establish protocol and appropriate utilization.
