Thetford Town School District Annual Meeting

The legal voters of the School District of Thetford, in the County of Orange and State of Vermont are hereby notified and warned to meet at Thetford Town Hall, in the Town of Thetford, on Tuesday, March 2, 2021 to vote by Australian ballot on the following Articles beginning at 8:00 AM and closing at 7:00 PM.

ARTICLE 1: Shall the voters of the Thetford Town School District authorize the Board of School Directors to borrow money in anticipation of revenues for school expenses?

ARTICLE 2: Shall the voters of the Thetford Town School District approve the school board to expend nine million, one thousand, seven hundred five dollars (\$9,001,705) which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$18,676 per equalized pupil. This projected spending per equalized pupil is 2.03% higher than spending for the current year.

A public informational hearing will be held on the above Australian ballot articles on February 27, 2021 beginning at 1:00 PM by Zoom.
