

ANNUAL MEETING
OXBOW UNIFIED UNION SCHOOL DISTRICT
April 13, 2021

The legal voters of the Oxbow Unified Union School District (the "District"), comprising the legal voters, respectively, of the Towns of Bradford and Newbury, are hereby NOTIFIED AND WARNED to meet at their respective polling places, Bradford Academy Auditorium and Newbury Town Office, from 10:00 AM (when the polls will open) to 7:00 PM (when the polls will close) to vote by Australian ballot on the following Articles:

ARTICLE 1: To Elect a Moderator for a term of one (1) year.

ARTICLE 2: To elect a Clerk for a term of one (1) year.

ARTICLE 2: To elect a Treasurer for a term of one (1) year.

ARTICLE 3: To elect two school directors of said District (1 to represent the Town of Bradford and 1 to represent the Town of Newbury) each for three-year terms to expire 2024.

ARTICLE 4: Shall the voters of the Oxbow Unified Union School District authorize the school board to expend seventeen million, one hundred seventy-one thousand, nine hundred sixty-eight dollars (\$17,171,968) which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$18,044 per equalized pupil. This projected spending per equalized pupil is 1.71% higher than spending for the current year.

ARTICLE 5: Shall the voters authorize the School Board to borrow money in anticipation of tax receipts for the 2021-2022 school year?

A public informational hearing will be held on the above Australian ballot article on **April 5, 2021** beginning at 6:00 PM via Zoom. There will be another public informational meeting on **March 24, 2021** at 6:30 pm via Zoom, in addition to the meeting the week ahead of the vote.

The legal voters of the Oxbow Unified Union School District are further notified that voter qualification and registration relative to said Annual Meeting shall be as provided in Section 706u of Title 16 and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.

Ballots will **not** be mailed to all voters. To request an absentee ballot please contact your Town Clerk's Office.


