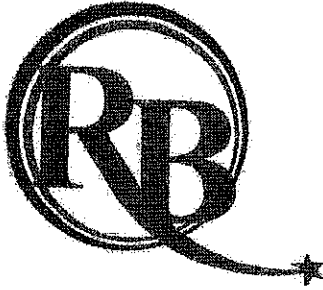

The successful bidder will be notified after the bid opening and subsequent approval by the District at its regular business meeting.




SUBMISSION OF BID RESPONSE


All bids become the property of the Orange East Supervisory Union.
