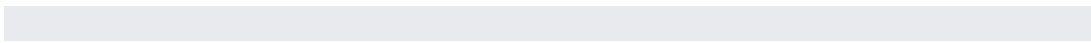

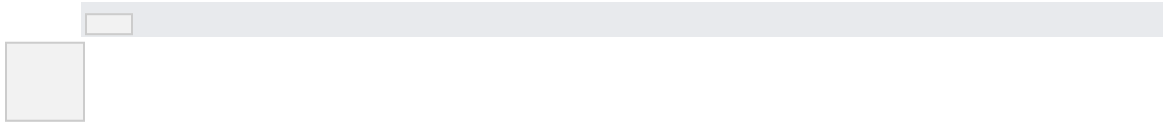

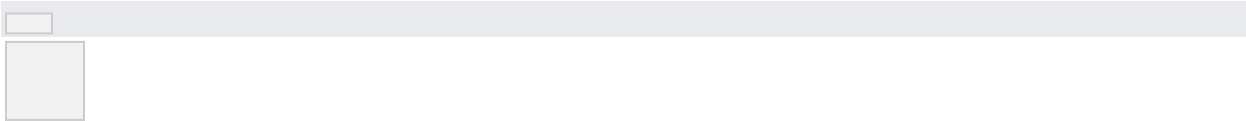

I am not entirely sure what your question is. But we addressed the voting options in the informational meeting on the 11th.

In May the board talked about how they wanted to handle this vote prior to warning it. The board had heard from community members that wanted to have an in person meeting. In addition when the OUUSD was formed the district voters voted that all district votes would be floor votes not Australian ballots. For these reasons the board voted to have an in person meeting/vote. We did find out after warning the meeting that we could have through Act 162 chosen an Australian ballot. So again the board discussed the voting options on the 11th. The board voted to move the meeting/vote outside rather than re-warn the meeting to use an Australian ballot. The timing of this vote was planned in effort to allow the school children access to the land as close to the start of school as possible. We have been in contact with the town offices and they are both doing Voter list purges and would not have availability for Australian ballot votes until late September or October due to that process.

All of these board conversations and votes are in our minutes as well as the recordings of the meetings which are on the website [oesu.org](http://oesu.org) under OUUSD. I am sure you know that it is not possible to please everyone. Inevitably someone would prefer a different option.

We would really like to sit down with you and go over this and other concerns you may have.

I was communicating w Will Senning at the office of secretary of state for Vermont yesterday who informs me that the rule allowing both Australian and absentee ballots is in effect through the end of 2021. I believe it is, and remains, the duty of the board to have advised the voters, in their entirety, prior to a meeting, of this. I know personally of one senior citizen in Bradford who called that office, town clerk, to ask for such a ballot and was told no.

You made mention of an emergency rule at the Aug 11 meeting but never stated that we the voters could ask for and utilize the process.

I believe you have failed in your duty to us.

How many voters may well have marked a ballot and returned same to the town clerks?

I think on this basis of the board's duty to warn, but failure to do so that the vote of Aug 17 must be voided and redone.

Neither of the town clerks were aware of this option until I brought it to their attention. I did not get confirmation from the secretary of states office until the week before our informational meeting on August 11. The board discussed this in open session and it is up to the board to make this choice. In the past year and a half guidance has been fluctuating on a regular basis it is very difficult to keep track of all of the options available. I understand that it's frustrating for some and it's frustrating for those of us trying to make decisions. I do believe the board did the best that we could given the circumstances.

I understand there may people who would prefer to have an Australian ballot and absentee ballot choice. We are allowed that option through the end of the year but the reality is the district charter requires a floor vote. Going forward people do need to understand that this is the way the votes are handled for this district.

Sukie, please understand I'm not trying to be difficult I'm just trying to help you understand the complexities of making decisions as guidance and options change. As local board members we do the best we can with the information that we have at the time. We do try to take into account community input but in the end we have to make a choice. No matter what choice we make there will be people who don't agree.

Please let me know a day and time that may work for you to try and get together to discuss concerns.

You may pass this information on to anyone asking about voting at an OUUS District Annual or Special Meeting.

The Special Meeting of the District was carried out as the Articles of Organization, Roberts Rules, and state law require, as a "traditional town style" meeting, where each article is moved, discussed, and voted on.

When Article 2 of the Warning was read, a voter asked for a paper ballot. Since seven (7) voters agreed, according to state law, following discussion of the Article, voting took place by paper ballot, each person being checked off on their town checklist, as they dropped their ballot in the box. An announcement was made, as is normally done, giving a last chance to vote, before the ballot boxes were closed, and the ballots co-mingled and counted.

The person who is asking about not being able to vote, was very misinformed, as there is no specific period of voting during a traditional town meeting style vote from the floor. (Had the vote been by voice vote, as Article 3 was, the chance to vote was only during a 30 second period).

Also, note that relevant Amendments to Articles being voted on may be moved, seconded, discussed, and if requested by seven voters be voted on by paper ballot; so several paper ballots are possible, with no specific time for each when any vote is taken.
